Sub: **Grant of Conditional Permission to Shri Lal Bahadur Shastri Smarak Govt. Ayurveda College, Jawahar Nagar, Handia, Allahabad-221503, Uttar Pradesh with 75 seats (including EWS) in UG (BAMS) course for the academic session 2020-21 under section 13A/13C of the IMCC Act, 1970- reg.**

Sir/Madam,

I am directed to refer to the Ministry's letter No. L-14014/373/2019- EP (1), L-14013/5/2018-EP (1) dated 06.07.2019 related to admission matter for the academic year 2019-20, intimating certain requirements to be fulfilled by the college for consideration of permission for the academic session 2020-21.

2. Further, refer to the CCIM's letter No.Ref.3-4/2020-Ay. (10) dated 25.09.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. On examining the same in terms of Regulation 3 of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016”, provisions under the IMCC Act, 1970, relevant regulations made thereunder, it is found that the College is fulfilling notified and approved criterion for granting Conditional Permission for UG (BAMS) course.

3. It has, therefore, been decided by the Central Government to grant Conditional Permission to Shri Lal Bahadur Shastri Smarak Govt. Ayurveda College, Jawahar Nagar, Handia, Allahabad-221503, Uttar Pradesh for conducting 75 seats (including EWS) in UG (BAMS) course for the academic session 2020-21 under Section 13C/13A of the IMCC Act, 1970.

4. It is further informed that minimum 15% of the permitted intake capacity of 75 UG (BAMS) seats shall be treated as all India quota. The counseling for seats under all India quotas shall be conducted by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State. If any seats are not filled up in the Central Counseling, the same shall be transferred to the said Counseling Authority to admit students as per their rules/ reservation policies/norms. **The permission of the college stands**
