**Subject:- Grant of conditional permission to Shri Lal Bahadur Shastri Smarak Govt. Ayurvedic College & Hospital, Handia, Allahabad-221503, Uttar Pradesh (AYU0250) with 60 seats (75 seats including EWS) in UG (BAMS) course under section 28 of the NCISM Act, 2020 for the academic session 2022-23 and relevant regulations thereunder in respect of appeal dated 14.11.2022-regarding.**

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

- This is with reference to the first appeal filed by Mr. Prakash Chandra Saxena, Director of Ayurved Service, Govt. of Uttar Pradesh vide letter ref. no. 2171 dated 14.11.2022 to the commission in respect of denial of conditional permission issued to the 07 Ayurveda Government colleges of Uttar Pradesh namely Bundelkhand Govt. Ayurvedic College & Hospital, Gwalior Road, Jhansi-284001, Uttar Pradesh (Inst. ID-AYU0246), Shri Lal Bahadur Shastri Smarak Govt. Ayurvedic College & Hospital, Handia, Allahabad-221503, Uttar Pradesh (AYU0250), Government Ayurvedic College & Hospital, Atarra-210201, Dist. Banda, Uttar Pradesh (Inst. ID-AYU0247), Govt. Ayurvedic College & Hospital, Sampurnanand Sanskrit University, Varanasi- 221002, Uttar Pradesh (AYU0258), State Ayurvedic College & Hospital, Tulsidas Marg, Lucknow-226001, Uttar Pradesh (AYU0244), Swami Kalyandev Government Ayurved College, Rampur, Muzaffarnagar-251001, Uttar Pradesh (AYU0249), Lalit Hari State P.G. Ayurvedic College & Hospital, Pilibhit- 262001, Uttar Pradesh (AYU0245) for conducting UG and UG&PG courses as the case may be due to not fulfilling the basic eligibility criteria in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" and Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016, provisions under the NCISM Act, 2020 and relevant regulations thereunder due to non availability of teaching, non-teaching staff, hospital staff and other shortcoming as mentioned in denial orders passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- Thereafter the said appeal was placed before the Chairman, NCISM and Chairman NCISM constituted a Hearing Committee and provided an opportunity of hearing to the college. Accordingly, the letter was sent to The Director, Directorate of Ayurveda, Government of Uttar Pradesh vide commission letter no. NCISM/Comm./Appeal/(2022-23) dated 22.11.2022 to appear before the designated hearing committee as constituted by the Chairman, NCISM on 25.11.2022 in respect of appeal filed under section 10(1)(g) and section 24(3) of the National Commission for Indian System of Medicine ACT, 2020 and to produce all relevant valid documents/records/ proof to substantiate the claims and make written submission and submit an authenticated copy of evidence/verifications to commission with shortcoming wise clarifications mentioned in the denial orders passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM. The proceeding of appeal was held virtually on 25.11.2022 at 03:00 PM and on behalf of Govt. of Uttar Pradesh, Mr. Prakash Chandra Saxena, Director of Ayurved Service, Govt. of Uttar Pradesh, attended the hearing.
- The hearing committee sought clarification from the representatives of Govt. of Uttar Pradesh regarding shortcomings mentioned in the denial orders passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM, which is as under:-

4. The submission made by the Director of Ayurveda Service, Govt. of Uttar Pradesh was placed before the designated hearing committee and hearing committee sought clarification regarding the shortcomings mentioned in the denial orders and also asked for the compliance of Shortcomings and asked the representatives to submit the affidavit regarding their assurance in respect of fulfillment of all requisite as mentioned in the denial orders passed by the Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
5. In response of the same, Director of Ayurveda Service, Govt. of Uttar Pradesh submitted the affidavit vide certificate no. IN-UP68197240685664U on 03.12.2022 with the affirmation that Director of Ayurveda Service, Govt. of Uttar Pradesh will fulfill all shortcomings with regards to Non-Availability of Teaching, Non-Teaching, Hospital staff, less availability of general and essential equipments/instruments and other shortcomings mentioned in the denial orders issued to the 07 Ayurveda government colleges of Uttar Pradesh. The Director of Ayurveda Service, Govt. of Uttar Pradesh also affirms that the shortcomings will be fulfilled by dated 31st December 2022.
6. Hence, in view of the affidavit submitted by the Director of Ayurveda Service, Govt. of Uttar Pradesh vide certificate no. IN-UP68197240685664U on 03.12.2022, the Chairman, NCISM directed the President, Medical Assessment and Rating Board for Indian System of Medicine, NCISM vide no. NCISM/Comm./Appeal/(2022-23)(U.P) dated 15.12.2022 to grant conditional permission to **Shri Lal Bahadur Shastri Smarak Govt. Ayurvedic College & Hospital, Handia, Allahabad-221503, Uttar Pradesh (AYU0250)** under section 28 of NCISM Act, 2020 for the academic session 2022-23.
7. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine, NCISM to issue conditional permission to **Shri Lal Bahadur Shastri Smarak Govt. Ayurvedic College & Hospital, Handia, Allahabad-221503, Uttar Pradesh (AYU0250)** with **60 seats (75 seats including EWS) in UG (BAMS) course under section 28 of the NCISM Act, 2020 for the academic session 2022-23 on the basis of affidavit vide certificate no. IN-UP68197240685664U on 03.12.2022 submitted by the Director of Ayurveda Service, Govt. of Uttar Pradesh**, subject to following condition:-
  - (i) It is further informed that minimum **15%** of undergraduate seats of the permitted intake capacity of **60 seats (75 seats including EWS)** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
9. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
10. The following requirements should be fulfilled by the college by 31st December, 2022 **and send a compliance report to get permission for the session 2023-24:**
  - i) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - ii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
  - iii) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in to; and

11. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
